Thank you for visiting our website. We are committed to protecting and respecting your privacy.

This Privacy Policy sets out the basis on which we process any personal information we collect about you or that you provide to us.

We may change this Privacy Policy from time to time, so please check back frequently.

About us

This website is operated by MAP estate agents. For the purposes of UK data protection law, the data controller is MAP estate agents of Gateway Business Centre, Wilson Way, Barncoose, Redruth TR15 3RQ.

Information we collect about you

We collect and process the following information about you:

- Information you provide to us. You can provide us with information about you by filling in forms on our website or by contacting us by telephone, email or otherwise. The information you provide to us may include your name, address, email address, telephone number and any other information you choose to provide.
- Information we collect about you. When you use our website, we automatically collect information about you, your computer or mobile device, your IP address and information about how you use our website and other websites.

We may combine this information with other information you provide to us or which we collect about you.

How we use your personal information
